## **TREASURER'S REPORT**

Wesley Schuhknecht reported on the financial status of the association. The budget shortfall was noted. It is due largely to landscape items. \$17,000 was paid by the developer and will be used to cover the 1999 budget shortfall.

## **OLD BUSINESS**

#### Settlement Payout

On June 23, 1999, we received \$17,000 from the developer. This has been deposited into the appropriate accounts. Approximately \$15,000 will be used towards the 1999 budget shortfall.

#### Irrigation Update

A solenoid was blown and had to be replaced. Therefore, some areas were without irrigation for a week or so. The solenoid has been replaced and everything is back on schedule.

#### **Bulletin Board**

The bulletin board was put in by the Master Association and placed at the entrance to the Pool / Tennis parking area. All six associations will use this board. Plantings will be done around the base.
