Directors present: Allen Butler, James Calamari, Joe Gardner, Ken Paa, and John Remmel.

Also Present: Tom Krieser, Ability Management Company as Recording Secretary, and seven other owners.

Call to order: Ken Paa called the meeting to order at 7:01 p.m. and offered his warm welcome to all owners and the new Board members.

Certifying Quorum for Directors. A full quorum was established.

Proof of Notice: Notice of the meeting and Agenda were posted, in accordance with Florida Statutes, and our Documents.

On a motion by James, seconded by Allen the minutes of the Board Meeting dated March 6, 2012 and previously circulated were unanimously approved.

Allen then presented the Treasurer's report thru March 31, 2012. His report is attached for reference, as is the petty cash reconciliation. Overall, our situation is good with a surplus compared to Budget. Allen requested that the petty cash be replenished in the amount of \$343.30 and charged to accounts as described in his memo to the Board On a motion by Ken, seconded by James, Allen's report and request were unanimously approved. Joe asked for a clearer explanation of the delinquency collection and foreclosure process and this was provided.

Landscape Committee. Jocelyne LaRochelle reported only very limited activity since the last meeting.

The President's report followed. Ken brought up a number of points. The most important was about the "wall" and who is responsible. With a new Master Board Ken is hoping that a sensible resolution might be possible and will work towards that end. He also mentioned that he attended a number of meetings concerning the "Wizard" property. On a motion by Joe, seconded by James and unanimously approved Ken was authorized to extend the support of Walden Shores assuming that concerns (including the possible issue of U-turn traffic into Walden Oaks) are satisfactorily addressed. Ken then went on to say that our documents require Walden Shores to have an ARC (Architectural Review Committee) but we never had one. He proposed the idea that eliminating duplication by asking the ARC of the Master to also serve the needs of our Association should be considered. On a motion by Allen, seconded by John, this motion was unanimously approved. Ken then stated that the Wall Liaison Committee was chaired by Bruce MacLaren and the Wall Committee, assisted by Lois Jones. We need another member and this will be advertised and asked for in the next Newsletter.

Other business: Allen has been working on a web-site for both Walden Oaks and the sub-Associations. In order to download valuable information an owner needs a password which can be obtained by containing Allen. Jocelyne requested that Agenda's and the Meeting Notice be distributed by e-mail. This was agreed and this will be done. Finally Roger reminded the Board that last year the gutter cleaning was forgotten. Ken reassured all owners that this oversight will be corrected this coming fall when the walk-ways and driveways get pressure washed.

Next meeting: The next Board meeting shall be held on May 8, 2012 at 7 p.m.

Adjourn: John made a motion to adjourn. Jim seconded the motion, and all other present Directors concurred.

The meeting was adjourned at 8:15 p.m.
